**MOTION FOR LEAVE TO FILE ENTRY OF
APPEARANCE OF GREGG P. LESLIE**

Pursuant to Fed. Cir. R. 47.3(c)(1), *amici* The Reporters Committee for Freedom of the Press et al. respectfully move the Court for leave to file an Entry of Appearance of Gregg P. Leslie in this case, for the purpose of presenting oral argument at the March 26, 2013, hearing. The Notice of Appearance and Response to Oral Argument Order have been submitted with this brief.

This Court's order allowing *amici* to participate in oral arguments was filed on March 14. Counsel of record for *amici* The Reporters Committee *et al.* is not available for the March 26 hearing, and requests that Gregg P. Leslie, a staff attorney and legal defense director of The Reporters Committee, argue in his place.

Counsel for the other *amicus* participant in this case, The First Amendment Coalition, has agreed to share time with *amici* the Reporters Committee *et al.*, consistent with this Court's March 14 order.
